To reduce the excessive cost of operating the fund, we see the following options as possibilities:

1. Sell existing trust deeds from the portfolio to the shareholders in exchange for their shares in the fund. Some shareholders are experienced trust deed investors and would be willing to add the trust deeds to their existing personal portfolio of trust deeds.
2. Sell the fund to an existing fund that invests in trust deeds so shareholders would exchange their shares of Emvest for shares of the new fund.
3. Allow shareholders to form a new management team, with express limitations on their expenses and requirements for accounting.

If the receiver is left in place, we feel that he should be required to do the following:

1. Since the court expenses are essentially over, and since the expense of finding new loans is over, reduce the receiver's total cost of operation to no more than 3% of the gross income of the fund.
2. Provide more information about the quality of the loans, such as appraised value of the properties, loan-to-value ratio of the properties.
3. When trust deeds are sold for less than full value, existing shareholders should be offered the option to buy them before they are offered to outsiders.
